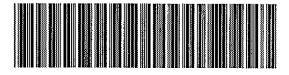

ARTICLES OF INCORPORATION

OF

UNIVERSAL HOME BUILDERS, INC.

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I

Name

The name of the corporation is UNIVERSAL HOME BUILDERS, INC.

ARTICLE II

Commencement and Duration of corporate Existence

The Corporation shall commence its corporate existence on the date of filing of these Articles of Incorporation with the Secretary of State, whichever shall be effective, and shall have perpetual existence.

ARTICLE III

General Purpose

The purpose for which the corporation has been formed is for the purpose of temporary and permanent employment placement and all other lawful business.

ARTICLE IV

Capital Stock- Voting and Non-Voting shares

The maximum number of non-voting shares of stock that the corporation is authorized to issue is one thousand (1,000) shares of common stock having \$1.00 par value. The consideration to be paid for each share shall be fixed by the Board of Directors. Common stock of the corporation shall be issued as "small business corporation" stock in accordance with the plan or plans under the provisions of Section 1244 of the Internal Revenue Code of 1986. The stock shall be in two classes,

the capital stock as above which shall be non-voting, and voting shares, consisting initially of three (3) authorized voting shares.

ARTICLE V

Initial Principal Place of Business

The street address of the initial registered office of the corporation shall be 10914 Mystic Point #204, Orlando FL 32836 and the name of the initial registered agent of the corporation at such address is JACQUELIN LOUIS.

The corporation shall have two (2) directors. The number of directors may thereafter be increased or decreased from time to time in accordance with the By-Laws of the corporation.
