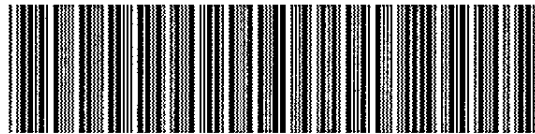

ARTICLES OF INCORPORATION

ARTICLE 1

Name: The name of the corporation is CURTIS DRAWDY ENTERPRISES, INC.

ARTICLE 11


Amendments:

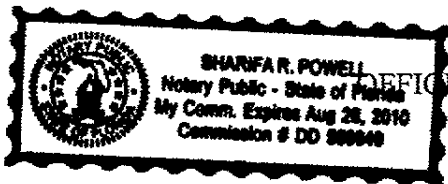
