**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of the corporation is FLAT FEE, INC., and the principal address and principal place of business is 12513 BASSBROOK LANE, TAMPA, FLORIDA 33626.

**ARTICLE II - REGISTERED OFFICE AND AGENT**
