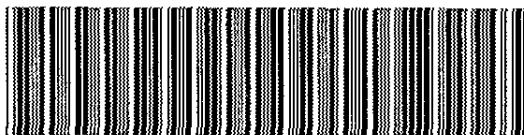

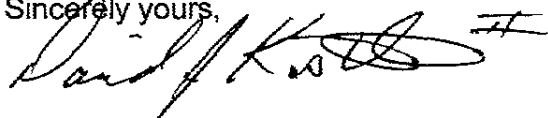

**ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME

The name of the corporation is:

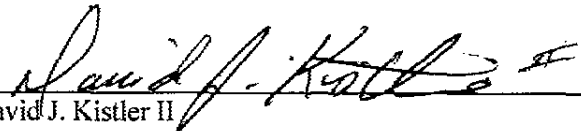

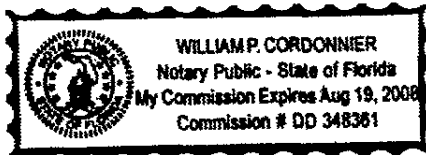
