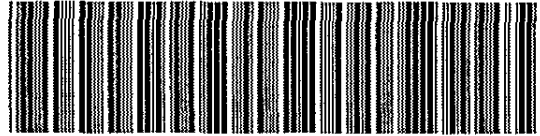

***ARTICLE I - NAME***




