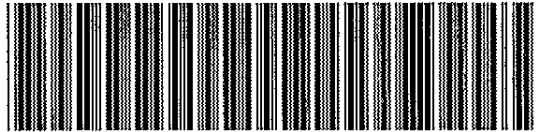

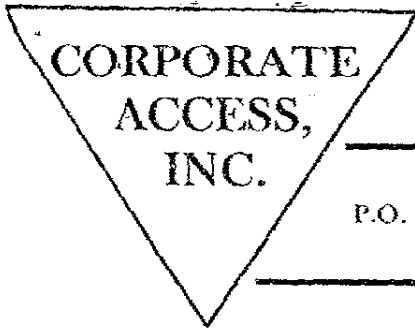

Article I
