#### ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Art?-cles of Incorporation.

## ARTICLE I - NAME

Section 1.1 Name. The name of the corporation is K.E.D.D. Trucking, INC.

# ARTICLE II - INITIAL PRINCIPAL OFFICE AND MAILING ADDRESS

Section 2.1 <u>Initial Principal Office and Mailing Address</u>. The initial principal office and mailing address is 4666 Rosemary Street Middleburg, Florida 32068.

#### ARTICLE III - DURATION

Section 3.1 <u>Duration</u>. This corporation shall exist perpetually. Corporation existence shall commence on January 1, 2007.

## ARTICLE IV - PURPOSE
