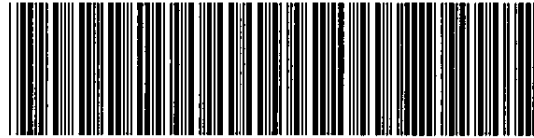

The undersigned incorporator, who is licensed or otherwise legally authorized to practice the profession of veterinary medicine in the State of Florida, associates himself with the intention of forming a professional corporation in accordance with the Florida Professional Service Corporation and Limited Liability Company Act, and adopt the following articles of incorporation for the corporation:

Effective Date

Jan. 1, 2007

ARTICLE I - NAME

The name of this corporation is **RICHARD D. HILL, DVM, P.A.**, located at 1025 Seminola Blvd., Casselberry, FL 32707.

ARTICLE II - PRINCIPAL OFFICE AND INITIAL REGISTERED AGENT

The street address of the initial registered office of this corporation is 1025 Seminola Blvd., Casselberry, FL 32707, and the name of the initial Registered Agent of this corporation located at that address is RICHARD D. HILL.

ARTICLE III - DURATION

This corporation shall exist perpetually, commencing on January 1, 2007, which shall be the effective date of incorporation for this corporation.

ARTICLE IV - PURPOSE

This corporation is organized for the following purposes:

- a. To engage in the practice of veterinary medicine as a professional corporation and to own and operate a veterinary medical clinic for the purposes of providing veterinary medical care and treatment.

b. To promote veterinary medical, surgical, and scientific research and knowledge; to furnish related laboratory and clinical services; and to own real and personal property, enter into contracts, and engage in any lawful business necessary for the rendering of the professional veterinary medical services.

c. To do everything necessary, proper, or convenient to accomplish any of the purposes set forth in these articles, and to do every other act incidental to the corporate purposes which is not forbidden by Florida laws or by the provisions of these articles of incorporation.

The purposes of this corporation shall be carried out only through officers, employees, and agents, each of whom is licensed or otherwise legally qualified to render professional medical services in the State of Florida.

ARTICLE V - CAPITAL STOCK

This corporation is authorized to issue 7,500 shares of common stock at \$1.00 par value, which shall be designated "Common Shares".

ARTICLE VI - POWERS

This corporation shall have all of the rights and powers now or subsequently conferred on professional corporations by the laws of the State of Florida.

ARTICLE VII - INCORPORATOR

ARTICLE VIII - BOARD OF DIRECTORS

The corporation is to be managed by a board of directors. This corporation shall have one

(1) director initially. The name and address of the initial director of this corporation is:

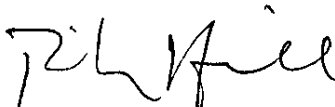

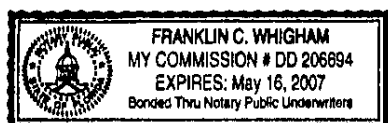


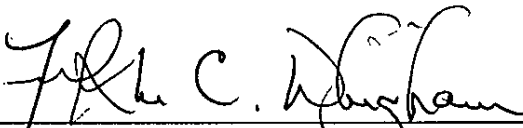
