The corporation shall indemnify any officer or director to the full extent permitted by law.

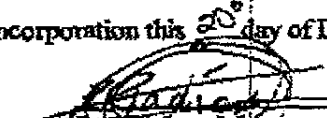
ARTICLE XI - PREEMPTIVE RIGHTS
