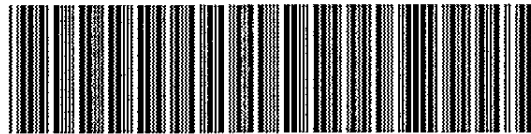

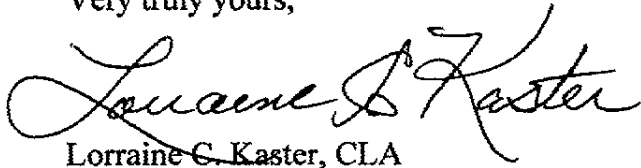

ARTICLE I - Name

The name of the corporation shall be: **HAYASHI ASSETS MANAGEMENT, CORP.**

ARTICLE II - Duration

This corporation shall exist in perpetuity commencing on the date of execution and acknowledgment of these Articles.

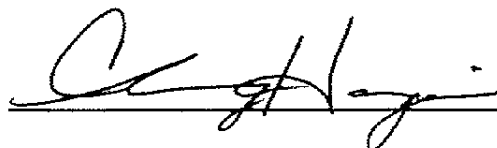
ARTICLE VIII - Principal Place of Business

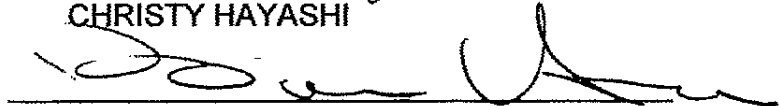
