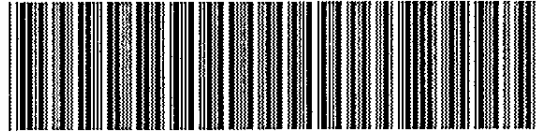

ARTICLES OF INCORPORATION

We, the undersigned, as proper persons acting as incorporators of a corporation under the laws of the State of Florida, adopt the following articles of incorporation:

Article I

The name of the corporation is: AAA Spray and Pressure Service Center, Inc.

Article II

The period of its duration is: indefinitely.

Article III

The purpose of the corporation is: to retail and to repair spray and pressure cleaning equipment and supplies.

Article IV

The aggregate number of authorized shares is: 500 shares par-value \$1.00.


