ARTICLES OF INCORPORATION OF NEWPORT STAR REINSURANCE COMPANY

SFC3FT6 TO THE 25 59

Pursuant to Sections 607.1801, 607.0120, and 607.0202 of the Florida Business Corporation Act (the "FBCA"), Newport Star Reinsurance Company (the "Corporation") hereby adopted file following Articles of Incorporation (the "Articles of Incorporation") in connection with the Corporation's redomestication from the State of South Carolina to the State of Florida:

ARTICLE I Name

The name of the Corporation is Newport Star Reinsurance Company.

ARTICLE II Principal Office
