ARTICLE I

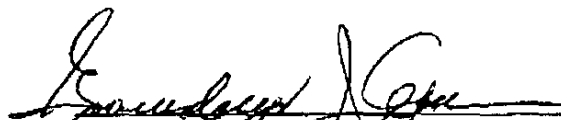
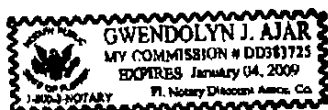
