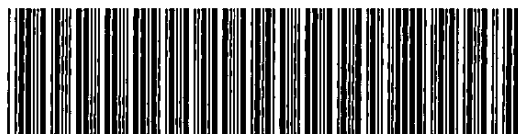

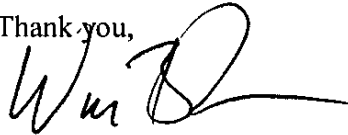

**ARTICLES OF INCORPORATION
OF
MERCER'S ENGINEERING CONSULTANTS, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: MERCER'S ENGINEERING CONSULTANTS, INC.

ARTICLE II

The street address of the principal office of the Corporation is 203 Monitor Drive, Beverly Beach, Florida 32136. The mailing address of the Corporation is Post Office Box 652, Flagler Beach, Florida 32136.

ARTICLE III

The specific purpose for which the Corporation is organized is for engineering, engineering consulting and/or all other legal purposes.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is one thousand (1000), all of which shall be Common Shares. The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.

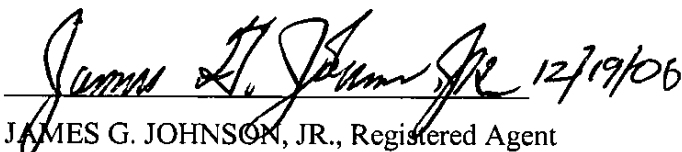
