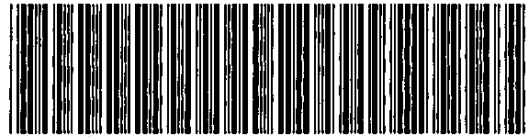

The undersigned, being a natural person, does hereby act as incorporator in adopting the following articles of incorporation for the purpose of organizing a corporation pursuant to the provisions of the State of Florida, and adopts the following articles of incorporation:

ARTICLE I: NAME

The name of the corporation is FKA RACING, INC. For convenience, the corporation shall be referred to in this instrument as the "corporation, and these articles of incorporation as the "articles".

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address is 3994 NW 36th Loop, Jennings, Fl. 32053.

ARTICLE III: PURPOSE

This corporation is organized for the purpose of encouraging and promoting the sport of go-kart racing as a form of recreation for youths and adults; to organize and conduct a series of go-kart racing events for recreative, competitive and instructive purposes at facilities suitable for such purposes; to establish and enforce rational competition rules and regulations and standards of conduct to foster safe racing and good sportsmanship among competitors; and for any and all lawful activity for which corporations may be incorporated under the provisions of the laws of the State of Florida.

ARTICLE IV: SHARES OF STOCK

The corporation shall have the authority to issue one share of corporate stock.

ARTICLE V: INITIAL OFFICERS

Jimmy L. Sims, 3994 NW 36th Loop, Jennings, Fl. 32053 shall serve as President of the corporation; Judith A. Sims, 3994 NW 36th Loop, Jennings, Fl. 32053 shall serve as Vice President and secretary of the corporation.

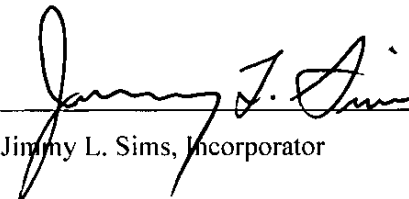
ARTICLE VI: REGISTERED AGENT

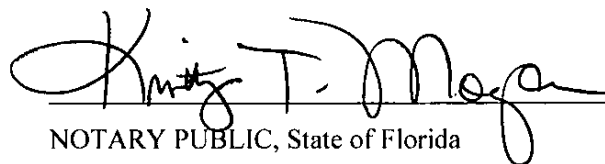

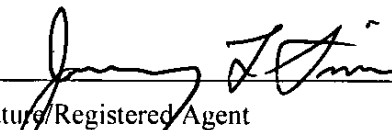

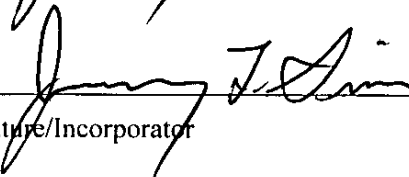
