CERTIFICATE OF INCORPORATION

The undersigned hereby associate us together for the purpose of becoming a corporation under the laws of the State of Florida. Providing for the formation, rights privileges immunities and liabilities of incorporation for

ARTICLE I

The name of the corporation should be:
