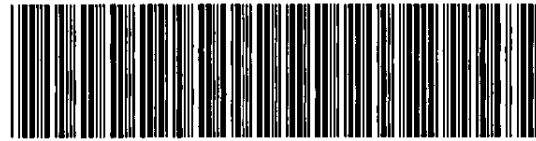

ARTICLE V


This corporation shall be managed by the stockholders of the corporation rather than be a Board of Directors.
