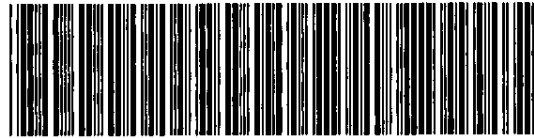

**ARTICLE IV – NEW CORPORATE NAME**


