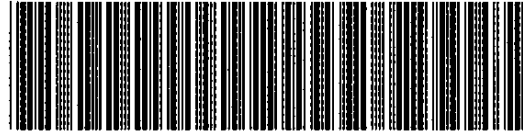

ARTICLE 1.

NAME

The name of this corporation is Advent Research, Inc.

ARTICLE 2.

PRINCIPAL OFFICE

The principal office and mailing address of this corporation is 6161 Dr. Martin Luther King Jr. Street North, St. Petersburg, FL 33703.

ARTICLE 3.

DURATION; EFFECTIVE DATE

This corporation shall exist perpetually, commencing as of January 1, 2007.

ARTICLE 4.

PURPOSES

This corporation may engage in any activity or business permitted under the laws of the United States of America and of this State.

ARTICLE 5.

CAPITAL STOCK

This corporation is authorized to issue Ten Thousand (10,000) shares of One Dollar (\$1.00) par value common stock.

AMENDMENT


