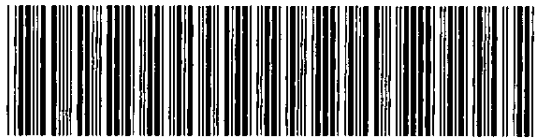

Separation Agreement

This separation agreement and general release is made and entered into by and between *Florida Mortgage Connection* and Yoemy Waller.

Whereas

Yoemy B. Waller has been employed by Florida Mortgage Connection as its Executive Vice President of Marketing since November, 2005;

for sound business reasons and in the best interests of both parties, it has been decided that *Yoemy Waller* will leave his or her position with Florida Mortgage Connection and resign;

Florida Mortgage Connection and Yoemy Waller do not anticipate that there will be any disputes between them arising out of Yoemy Waller's separation from Florida Mortgage Connection, but nevertheless desire to ensure a completely amicable parting and to settle fully and finally any and all differences or claims that might otherwise arise out of *Yoemy Waller's* employment with Florida Mortgage Connection and the termination of employment;

Florida Mortgage Connection does not normally provide severance or any kind of continuation pay or benefits to employees who resign; and

Now, therefore, in consideration of the mutual promises contained herein, it is agreed as follows:

1. *Resignation.* Yoemy Waller will resign from his or her position as *Executive Vice President of Marketing* no later than August 7th, 2007.
2. *Continuation of pay and benefits.* In consideration of this agreement, *Florida Mortgage Connection* agrees to pay Yoemy Waller after she resigns a marketing referral fee of \$500 for each residential customer deal that she brings or has brought to the Company and \$1,000 for each commercial customer deal. Likewise \$75 for each title services referred. It is understood that there will be no continuation of any other benefits (e.g., vacation or leave) after this time period.
3. *Confidentiality.* Each party agrees to keep the facts and terms of this separation agreement and general release in strict confidence and refrain from making any negative or critical remarks about the other party. Except for litigation arising out of the breach or enforcement of this agreement, this agreement shall not be admissible in any legal proceeding.
4. *References.* Yoemy Waller agrees to any requests for references will only be directed to Michael Dischner. Florida Mortgage Connection agrees that in response to such reference requests, positive or neutral references will be provided.


5. *No admission of wrongdoing.* This agreement shall not in any way be construed as an admission by the released parties of any acts of wrongdoing whatsoever against Yoemy Waller or any other person.


6. *Entire agreement.* This agreement and release sets forth the entire agreement between the parties hereto, and fully supersedes any and all prior agreements or understandings between the parties hereto pertaining to the subject matter hereof.

7. *Venue.* Any proceeding brought to enforce this agreement shall be brought in *Brandon Florida*
