P. 3 The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the Florida Professional Service Corporation and Limited Liability Company Act

ARTICLE I - NAME

The name of the corporation is David M. Wolpin, P.A. (the "Corporation"). .

ARTICLE II - EFFECTIVE DATE

These Articles of Incorporation shall be effective on January 1, 2007.

<u>ARTICLE III – ADDRESS</u>

The mailing address and principal office of the Corporation is 2523 Ponce de Leon Boulevard, Suite 700, Coral Gables, Florida 33143.

ARTICLE IV - NATURE OF BUSINESS
