The undersigned, acting as incorporator, hereby adopts these Articles of Incorporation and forms a profit corporation (the "Corporation") under Chapter 621 of the Florida Code, as follows:

1. NAME

The name of this corporation is:

CAROLINE M. WEBBER, D.D.S., P.A

2. TERMS OF EXISTENCE

The date when the corporate existence shall commence shall be the date of the execution of these Articles of Incorporation, and the Corporation shall have perpetual existence thereafter.

3. PURPOSE

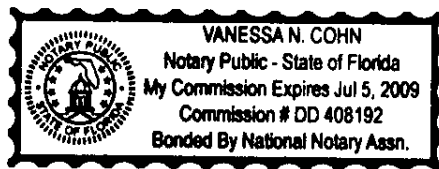
