ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the Florida Professional Service Corporation and Limited Liability Company Act.

ARTICLE I - NAME

The name of the corporation is Richard Jay Weiss, P.A. (the "Corporation").

. ARTICLE II - EFFECTIVE DATE

These Articles of Incorporation shall be effective on January 1, 2007.

ARTICLE III - ADDRESS

The mailing address and principal office of the Corporation is 200 East Broward Boulevard, Suite 1900, Fort Lauderdale, Florida 33301.

ARTICLE IV - NATURE OF BUSINESS
