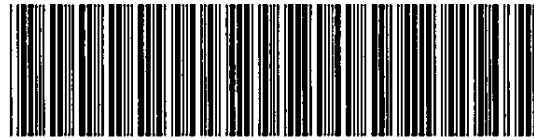

ARTICLES OF INCORPORATION
OF

ARTICLE I. NAME.

The name of this corporation is: D. D. CANVAS & UPHOLSTERY, INC.

ARTICLE II. NATURE OF BUSINESS AND POWERS.


