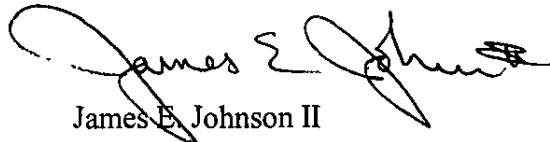

The undersigned subscriber to these Articles of Incorporation is a natural person, competent to contract, and hereby forms a Corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

Effective Date

Jan. 01, 2007

The name of the Corporation shall be JERRY R. SULLIVAN, C.P.A., P.A.

ARTICLE II - SPECIFIC PURPOSE

The purpose of this Corporation is to engage in every aspect of providing certified public accountant services , managing a certified public accountancy firm and all lawful activities related thereto.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time is One Hundred shares of common stock, each share having \$.10 par value per share.

ARTICLE IV - TERM OF EXISTENCE

This Corporation shall have perpetual existence.

ARTICLE V - EFFECTIVE DATE

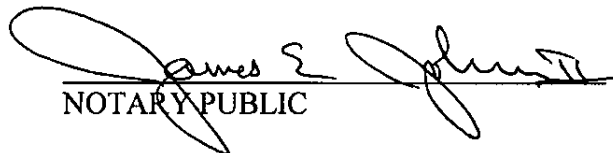

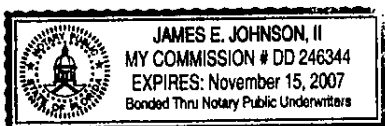

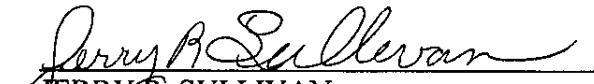
