#### ARTICLE I - NAME

The name of the Corporation is Esmildo E. Machado, M.D., P.A., (hereinafter, "Corporation").

#### ARTICLE II - PURPOSE OF CORPORATION

Such physicians are dedicated to the prevention of illness, injury, and disability, and to the promotion of healthy behaviors and improved quality of life. Public health physicians often have clinical and/or administrative roles in local or state health departments, federal or international health agencies, academic institutions, and for-profit health and health care organizations. While physicians enter public health with different clinical backgrounds, many have formal public health training and hold specialty board certification in preventive medicine, the combined art and science of getting and keeping people healthy. This corporation is created with the intent to profit.

#### ARTICLE VIII - SUB - CHAPTER S CORPORATION

Once this Corporation has elected to be and S-Corporation, none of the shareholders of this Corporation, without the written consent of all the shareholders of this Corporation shall take any action, or make any transfer or other disposition of the shareholders shares of stock in the Corporation, which will result in the termination or revocation of such election to be an S corporation, as provided in Sub-Chapter S of the Internal Revenue Code of 1986, as amended.

#### ARTICLE IX - SHAREHOLDERS' RESTRICTIVE AGREEMENT

All of the shares of sock of this corporation may be subject to a Shareholder's Restrictive Agreement containing numerous restrictions on the rights of shareholders of the Corporation and transferability of the shares of stock of the Corporation.

#### ARTICLE X - TERM OF EXISTENCE

This Corporation shall have perpetual existence.

#### **ARTICLE XI - VOTING RIGHTS**

Shareholders of the Corporation will have such voting rights as are provided in the By Laws of the Corporation.
