The undersigned, being a natural person, competent to contract and licensed to practice law in the State of Florida, acting hereby as incorporator for the purpose of establishing a Professional Service Corporation under the provisions and subject to the requirements of the laws of the State of Florida, particularly Chapters 607, Florida Business Corporation Act, and Chapter 621, Professional Service Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST: The name of the corporation (hereinafter called the "Corporation") is:
RONNIE ADILI, P.A.
- SECOND: The principal address and mailing address is as follows: 150 East Boca Raton Road, Boca Raton, Florida 33432
- THIRD: The Corporation is organized for the purpose of engaging in the practice of law in the State of Florida and any other state permitted by law, and all its' fields of specialization as engaged in by law pursuant to Chapter 621. The Corporation shall engage and render the professional services involved only through its' officers, agents, and employees who shall be attorneys in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as the Corporation.
- FOURTH: The Corporation is authorized to issue ONE THOUSAND (1,000) shares of common stock, par value \$ 0.10 per share. Shares of the Corporation's stock and certificates shall be issued only to attorneys in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional services as the Corporation.
- FIFTH: The Corporation shall have all the powers conferred upon corporations organized pursuant to the provisions of Chapters 607 and 621, Florida Statutes, as amended and supplemented.
- SIXTH: The Corporation is to have perpetual existence unless dissolved according to the law.
- SEVENTH: The Corporation shall have one director initially. The number of directors may be either increased or decreased from time to time as provided in the By-Laws but shall never be less than one. The name and address of the initial director of this Corporation is: Ronnie Adili, 150 East Boca Raton Road, Boca Raton, Florida 33432.


EIGHTH: The name and address of the person subscribing to these Articles of Incorporation is as follows:

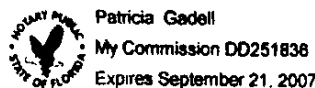
