I, the undersigned, desiring to form a corporation for profit pursuant to the laws of the State of Florida, do hereby certify as follows:

#### ARTICLE I

The name of the Corporation shall be:

### ARTICLE II

The Corporation shall be entitled to engage in any activity or business permitted under the laws of the State of Florida.

### ARTICLE III

The capital stock of the Corporation shall be divided into shares of \$.01 par value, with five thousand (5,000) shares of common stock authorized, and each share shall entitle the holder hereof to vote at any meeting of the stockholders. ### ARTICLE V

The Corporation shall have perpetual existence.

at such other places within or without the State of Florida as may be determined and deemed expedient by the Directors.
