This letter will confirm our conversation yesterday regarding the Articles of Incorporation and Articles of Correction for Guarantee Insurance Company ("Guarantee" or the "Company") which is in the process of redomesticating from the State of South Carolina to the State of Florida. After reviewing the Consent Order dated December 29, 2006 issued by the Florida Office of Insurance Regulation ("OIR"), providing for the redomestication of the Company to Florida, the South Carolina Department of Insurance construed the effective date of redomestication of the Company to be December 29, 2006, even though the Articles of Incorporation were not filed in Florida until January 5, 2007.

As you know, the Company's redomestication to the State of Florida would not be effective until the redomestication is first approved by the OIR and the Articles of Incorporation are filed with your office. After the Company's redomestication was approved by the OIR, the Company then filed a Certificate of Domestication, with Articles of Incorporation attached thereto, on January 5, 2007 with your office to redomesticate the Company in Florida. On January 19, 2007, the Company filed Articles of Correction because two pages that should have been submitted in the January 5, 2007 filing were inadvertently omitted.

The Articles of Incorporation that were submitted on January 5, 2007 also failed to set forth that the effective date of the Company's redomestication shall be December 29, 2006. The utilization of this effective date has been approved by both the OIR and the South Carolina Department of Insurance.
