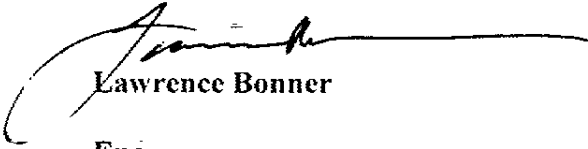

ARTICLES OF INCORPORATION

**ARTICLE I
CORPORATION NAME**

The name of the Corporation shall be:

**ARTICLE II
NATURE OF BUSINESS**

The Corporation may engage in or transact any or all activity of business permitted under the laws of the United States and of the State of Florida.
