ARTICLES OF INCORPORATION OF NO LIMIT DETAILING, INC.

The undersigned, incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby make and adopt the following Articles of Incorporation:

ARTICLE I - Name. The name of the Corporation shall be NO LIMIT DETAILING, INC.

ARTICLE II -- Address. The principal place of business and mailing address is 4699 N. State Rd. 7, Suite A-1, Tamarac, Fl 33319

ARTICLE III – Authorized Shares. The corporation is authorized to issue one class of shares which shall be called common shares. Common shares shall have unlimited voting rights and shall be entitled to receive net assets of the Corporation upon dissolution. The Corporation is authorized to issue 1000 common shares. Such shares shall be of a single class and shall have a par value of \$100.00 per share.

ARTICLE IV - Duration. The duration (term) of the Corporation is perpetual.

ARTICLE V - Purpose. The Corporation is organized, and shall be operated exclusively for the following purposes:

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
 - B. To do such other things as are incidental to the purpose of the Corporation or necessary or desirable in order to accomplish them.

C. To engage in the business of detailing Automobiles, Trucks, Vans and other vehicles.

ARTICLE VI - Initial Registered Office and Agent. The street address of the initial Registered Office of the Corporation is 4500 N. State Rd. 7, Suite 10/11, Lauderdale Lakes, Fl 33319, and the name of the initial Registered Agent at that address is Samuel A. Price.

ARTICLE VII - Initial Board of Directors. The number of directors constituting the initial Board of Directors is three (3). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one.
