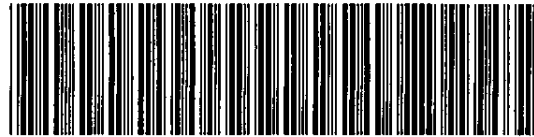

**ARTICLE VII. INDEMNITY**
