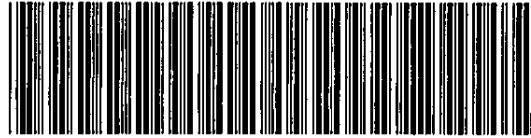

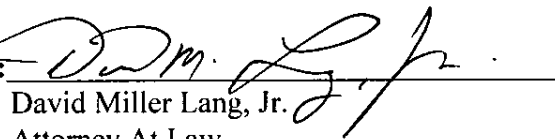

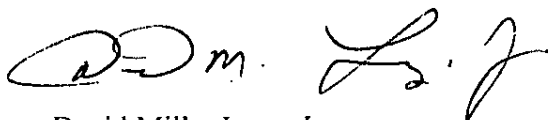

**ARTICLE I. CORPORATE NAME.**

The name of this Corporation is Weseman Engineering, Inc. .

**ARTICLE II. PRINCIPAL OFFICE.**

**ARTICLE IX. INITIAL DIRECTORS AND OFFICERS.**

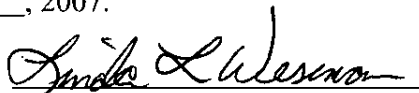

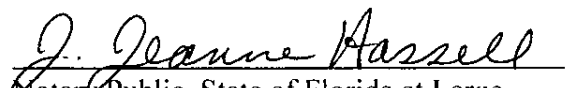
