ARTICLES OF INCORPORATION OF TONESTOPHONE, INC

ON THE PROPERTY OF THE PARTY OF

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE !

NAME, PRINCIPAL PLACE OF BUSINESS AND DURATION

The name of the Corporation is **TONESTOPHONE**, **INC** The principal place of business of the Corporation **2295 SOUTH HIAWASSEE RD #208**, **ORLANDO**, **FL 32835**. The duration of the corporation is perpetual.

ARTICLE II

REGISTERED OFFICE AND AGENT

The address of the registered office in the state of Florida is **682 MAITLAND AVE** in the city of **ALTAMONTE SPRINGS** in the County of **SEMINOLE**. The name of the registered agent at such address is **ANKITA PATEL**.

ARTICLE III

CORPORATE PURPOSE, POWERS AND RIGHTS

- 1. The nature of the business to be conducted or promoted and the purpose of the Corporation are to engage in any lawful act or activity for which Corporation may be organized under the Business Corporation Act of Florida.

- (b) In the event of voluntary or involuntary liquidation, dissolution of assets or winding up of the corporation, after distribution in full of the preferential amounts, if any, to be distributed to the creditors and holders of shares of preferred stock, if any such stock shall be authorized herein and issued, the holders of Common Stock shall be entitled to receive all of the remaining assets of the Corporation of whatever kind available for distribution to shareholders ratably in proportion to the number of shares of Common Stock held by them respectively. Incorporation, or to do any other acts or things as authorized, permitted or allowed by such legislative enactments.
