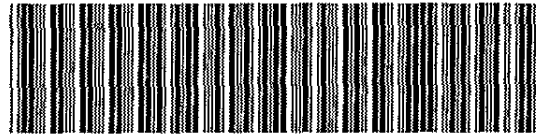


ARTICLES OF INCORPORATION

The undersigned, a natural person, does hereby form a corporation under the Florida General Corporation Act, and other laws of the State of Florida.

ARTICLE ONE

The name of the corporation is The BRAS-Plaza Strip, Inc. and it's business address is 357 Morse Plaza Street, Fort Myers, FL 33905

ARTICLE TWO

Subject to the laws of the State of Florida regarding Corporations, the Corporation may engage in commercial real estate rental and all activities and business permitted under the laws of the United States and of the State of Florida. The Corporation shall have all of the powers vested in a corporation organized under and existing by virtue of the laws of the State of Florida.

ARTICLE THREE

The maximum number of shares of stock which the Corporation is authorized to issue and have outstanding at any time is 100,000 shares of common stock having a par value of \$ .01 per share.

ARTICLE FOUR

The existence of the Corporation shall be perpetual.

ARTICLE FIVE

The street address of the principal office of the Corporation is 357 Morse Plaza Street, Fort Myers, FL 33095 and the street address of the Corporation's initial registered office is 4702 NW 120 Way, FL 33076, and the initial Registered Agent at that address is Kiruddinan Balasubramaniam.

## ARTICLE SIX

The Corporation shall have four director initially. The number of directors may be increased or diminished from time to time pursuant to the By-Laws of the Corporation, but shall not be less than one and more than eight.

## ARTICLE SEVEN

A director shall not be prohibited or disqualified from voting on any issue, at any time, by reason of the fact that the issue under consideration may involve any such director, personally, directly or indirectly, or that it may involve any person, firm, corporation or other entity in which such director has such a direct or indirect interest.

ARTICLE ELEVEN

These Articles of Incorporation may be amended in the manner provided by law. ARTICLE TWELVE

The initial By-Laws of the Corporation shall be adopted by a unanimous vote of the Board of Directors of the Corporation. Thereafter, the By-Laws of the Corporation may be amended, modified, or repealed as provided by the By-Laws.

ARTICLE THIRTEEN

Each shareholder of the Corporation shall be entitled to full preemptive rights to acquire his or her proportional part of any unissued or treasury shares of the Corporation, or securities of the Corporation convertible into or carrying a right to subscribe to or acquire shares, which may be issued at any time by the corporation.
