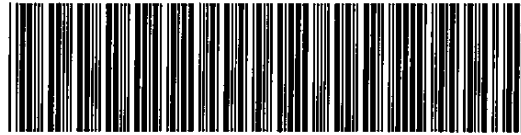

OF

ARTICLE I

CORPORATE NAME AND ADDRESS

The name of the Corporation shall be:

AMENDMENTS

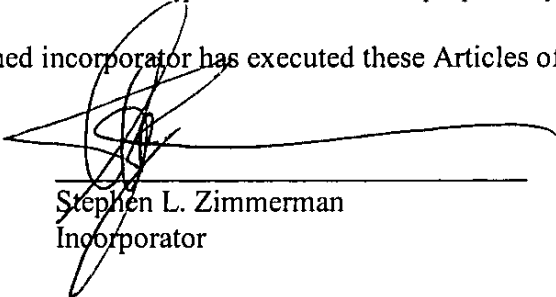
