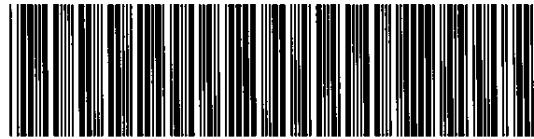

THE UNDERSIGNED, has executed the following document as incorporator of the above named ----
corporation, a corporation organized under the laws of the State of Florida, and all the right duties and
obligations of the undersigned as incorporator, and those of the corporation, are to determined in -----
accordance with the laws of the a State of Florida.

ARTICLE I

The name of this corporation shall be: CAD CONSTRUCTION GROUP, CORP

ARTICLE II

This corporation shall commence existence upon the filling of these Articles of Incorporation by the --
Department of State, State of Florida and shall have perpetual existence.

ARTICLE III

The general nature of business and objects and purposes proposed to be transacted and carried on by this
corporation are to do any and all of the things herein mentioned, as fully and to the same extent as natural
persons might do, viz:

deal in and with real or personal property or any interest therein, wherever situated;

To sell, convey, mortgage, pledge, create a security interest in, lease, exchange, transfer and
otherwise dispose of all or any part of its property and assets;

To lend money to, and use its credit to assist, its officers and employees in accordance with
Florida Statute S607.141;

To purchase, take. Receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ,
sell, mortgage, lend, ledge or otherwise dispose of and otherwise use and deal in and with

shares or other interest in, or obligations of, other domestic or foreign corporations, -----
associations, partnerships or individuals or direct or indirect obligations of the United States or
of any other government, state, territory, governmental district or municipality or of any -----
instrumentality thereof;

To make contracts and guarantees and incur liabilities, borrow money at such rates of interest as
the corporation may determine, issue its notes, bonds and other obligations and secure any of its
obligations by mortgage or pledge of all or any of its properties franchises and incomes;

To lend money for its corporate purposes, invest and reinvest funds and take and hold real and
personal property as security of the payment of funds so loaned or invested;

partnership, joint venture, trust or other enterprise.

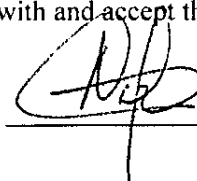
ARTICLE IV

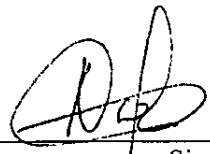
