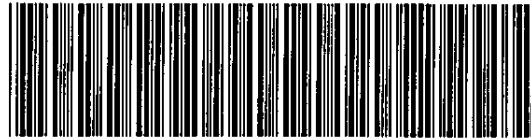



The undersigned Incorporator, for the purpose of forming a professional corporation pursuant to the provisions of Chapter 621, Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this corporation shall be and hereby declared to be Charles Richard Mehaffey, Jr. P.A.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business is 220 Sea Coast Lane, Ponte Vedra Beach, Florida 32082.
