# ARTICLES OF INCORPORATION OF D&I SERVICES, INC.

The undersigned, acting as the sole incorporator, desiring to form a corporation for pursuant to the Florida Business Corporation Act, adopts the following Articles of Incorporation:

# **ARTICLE I - NAME OF CORPORATION**

The name of the corporation shall be D&I SERVICES, INC.

# **ARTICLE II - TERM OF EXISTENCE**
