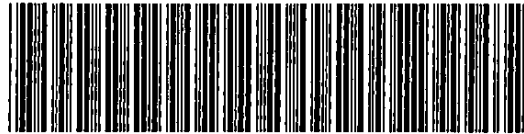

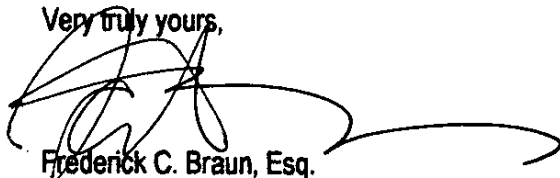

ARTICLE I. CORPORATE NAME

ARTICLE VII. PRE-EMPTIVE RIGHTS

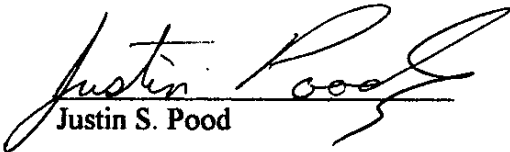

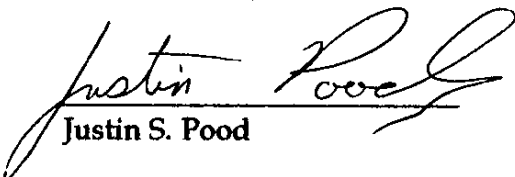

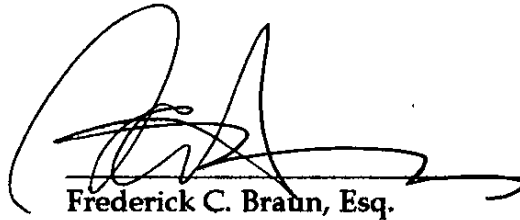
