ARTICLES OF INCORPORATION

ARTICLE I. - NAME AND ADDRESS

The name of this corporation is TJC Enterprises II, Inc. (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 3111 North Ocean Drive, No. 511, Hollywood, Florida 33019.

The power to alter, amend or repeal the Bylaws shall be vested in each of the Board of Directors and the shareholders of the Corporation.


ARTICLE IX. - INDEMNIFICATION


