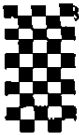

ARTICLES OF INCORPORATION

OF

GILBERTO PASTORIZA, P.A.

The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the Florida Professional Service Corporation and Limited Liability Company Act.

ARTICLE I - NAME

The name of the corporation is Gilberto Pastoriza, P.A. (the "Corporation").

ARTICLE II - EFFECTIVE DATE

These Articles of Incorporation shall be effective on the date filed with the Department of State.

ARTICLE III - ADDRESS

ARTICLE IV - NATURE OF BUSINESS


ARTICLE VIII - INCORPORATOR

ARTICLE IX - INCORPORATION OF PROVISIONS OF PROFESSIONAL SERVICE CORPORATION ACT


