# ARTICLES OF INCORPORATION VEREDA CARPENTRY, INC.

Contract of the Contract of th The undersigned hereby adopts the following Articles of Incorporation for the forming a corporation under the laws of the State of Florida.

# ARTICLE I NAME AND PRINCIPAL ADDRESS

The name of the corporation shall be: VEREDA CARPENTRY, INC., and the mailing address of the corporation shall be: 1749 NW 16<sup>TH</sup> Street, Miami, FL 33125.


