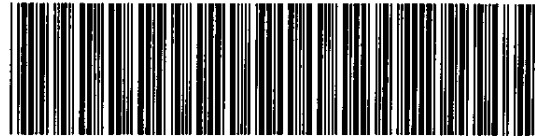

ARTICLES OF INCORPORATION

OF

ARTICLE 1 – NAME

The name of this corporation is R.E. Teacher Inc.

ARTICLE VIII – PREEMPTIVE RIGHTS
