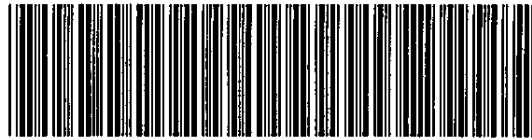

OF

ARTICLE I

The name of the corporation shall be SHED MUSIC, INC. and its mailing address shall be 2600 N.E. 35 DRIVE, UNIT W, FORT LAUDERDALE, FL 33308.




