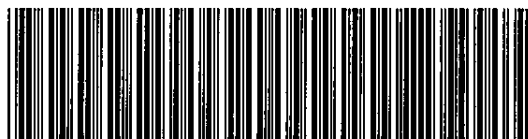

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article I

The name of this corporation is Harps and Bowls, Inc. The principal office and mailing address of the corporation are: 419 S. Dexter Avenue, Deland, Florida 32720.

Article II

The duration of the corporation is perpetual.

Article III

The general purpose of the corporation is to engage in and to transact all business which is lawful under the laws of the United States of America and the State of Florida.

Article IV

The aggregate number of shares which the corporation is authorized to issue is one thousand (1,000) shares. All such shares shall be of a single common class. Each share shall have a par value of one dollar (\$1.00).

Article V

The street address of the initial registered office of this corporation is 419 S. Dexter Avenue, Deland, Florida 32720 and the name of its initial registered agent at that address is Darrell L. Dement.

Article VI

The number of directors constituting the initial board of directors of the corporation is one. The number of directors may be increased or decreased from time to time in accordance with the corporation's bylaws but shall never be less than one. Article VIII


The corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation or any amendment to them.
