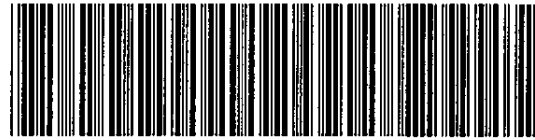

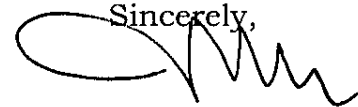

TUNZ A FUN OF CHIEFLAND, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, file these Articles of Incorporation to form a corporation for profit under the laws of the State of Florida.

ARTICLE ONE: NAME

The name of this corporation shall be TUNZ A FUN OF CHIEFLAND, INC.

ARTICLE TWO: GENERAL PURPOSE

The purpose for which this corporation is organized is to engage in any lawful business under the laws of the State of Florida and the United States of America.

ARTICLE THREE: CAPITAL STOCK

The maximum number of shares of stock this corporation is authorized to have outstanding at any time is 100 shares of common stock. All issued stock shall be held of record by not more than 35 shareholders. Stock will be issued and transferred only to (i) natural persons, (ii) estates, or (iii) a trust defined in IRC §1361(c)(2) (or its successor section). In addition, no stock shall be issued or transferred to a nonresident alien.

ARTICLE FOUR: INITIAL CAPITAL

The amount of capital with which this corporation shall begin business is in excess of \$500.00.

ARTICLE FIVE: EFFECTIVE DATE

The existence of the corporation shall begin immediately upon filing.

ARTICLE SIX: PRINCIPAL OFFICE; REGISTERED AGENT OFFICE AND ADDRESS

The street address of the principal office and the initial registered office of this corporation is 503 North Main Street, Chiefland, Florida 32626 and the name of its initial registered agent is LISA PEARCE, whose address is 503 North Main Street, Chiefland,

Florida 32626. The stockholders may from time to time designate such other address and place as the principal and registered office of such corporation and such other person as its registered agent, subject to requirements of Florida laws.

ARTICLE SEVEN: MANAGEMENT

The business of this corporation shall be managed by its stockholders rather than by a Board of Directors. In the management of the business of this corporation, the act of the stockholders representing the majority of the outstanding shares of the corporation entitled to vote, represented in person or by proxy shall be the act of the corporation. Each stockholder shall be entitled to one vote in person or by proxy for each share of voting stock held by her or him. A majority of the outstanding shares of the corporation entitled to vote, represented in person or by proxy, shall constitute a quorum at any meeting of the stockholders for the management of the business of the corporation.

The corporation shall have perpetual existence, or until dissolved on a vote of the shareholders as provided in these articles.

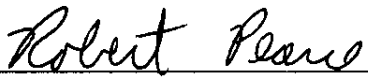
ARTICLE ELEVEN: AMENDMENTS
