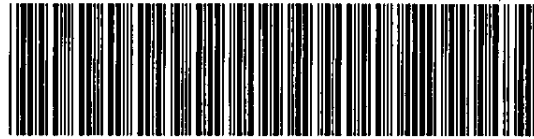

The undersigned Incorporator for the purpose of forming a corporation under Chapter 607

Florida Statutes, hereby adopt the following Articles of Incorporation:

ARTICLE I - NAME AND ADDRESS

The name of this corporation is GILILEO ROOFING SERVICE, INC. The principal place of business of the corporation is 1701 W. Memorial Boulevard, Lakeland, Florida 33815.

ARTICLE II - DURATION

The duration of the corporation is perpetual.

ARTICLE III - SHARES OF STOCK

The aggregate number of shares which the corporation is authorized to issue is One Thousand (1,000). Such shares shall be of a single class and shall have a par value of One Dollar (\$1.00) per share.


ARTICLE VIII - AMENDMENTS
