ARTICLES OF INCORPORATION OF

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE L NAME

The name of the corporation is Thomas Gray Maritime, Inc.

The principal place of business of this corporation shall be: 9 SW 13th Street, Ft. Lauderdale, FL 33315.

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.
