The undersigned, acting as the incorporator of a corporation, under the laws of the State of Florida, Florida Statutes, Chapter 607, and hereby sets forth and declares:

CHARTER

Article I

Name

The name of the corporation shall be BILLCAR OF SW FL, INC

Article II Principal Office

The principal place for the transaction of the corporation business shall be 127 SW 57th Terrace., in the City of Cape Coral, County of Lee, in the State of Florida, 33914, and the mailing address is the same. That said corporation shall have the right and authority to do business at such other place or places within or without the State of Florida as the corporation may, by resolution, designate.
